# Proposed resolution

"Subject to the approval of The Registry of Co-operatives & Associations the following changes are made to the Rules of Lampada Ski Club Co-operative Limited:

• Schedule 4 Part 1 Number of directors, composition of the board and term of office of directors Rule 11.1(a)

the words "The number of directors of the co-operative is ten (10) or such other number of directors as the members shall determine at a general meeting." are changed to

"The number of directors of the co-operative is eight (8) or such other number of directors as the members shall determine at a general meeting.

• Schedule 4 Part 3 – Retirement of directors Rule 11.7(a)

the words "The directors shall retire in rotation annually. In the first instance four shall retire, and then three and then three, with the sequence repeating thereafter. A retiring director shall be eligible for re-election."

are changed to

"The directors shall retire in rotation annually. In the first instance three shall retire, and then three and then two, with the sequence repeating thereafter. A retiring director shall be eligible for re-election."

#### Purpose of Special Resolution

The Board would like to reduce the number of Directors to eight (8) from 10. This will require rule changes passed at a general meeting.

If passed at our AGM the Rule change will be submitted to the NSW Fair Trading Registrar of Cooperatives for final approval and once that occurs it will become operative.

#### Members entitled to vote

Only Foundation and Ordinary members are entitled to vote on the special resolution. Provisional members are not entitled to vote.
